DYNAMICS OF UPCOMING SESSION

- ▶ Even year - typically bonding / policy year, but nothing is typical anymore
- ▶ Not the same legislature that we were looking at last December
 - ▶ 5 special elections, so far
 - ▶ 2 more to go
 - ▶ No impact to legislative control (so far . . .)
- ▶ Retirements for next session
 - ▶ 17 true retirements (12 Senate, 5 House)
 - ▶ 5 house members seeking Senate (3 open seats, 2 incumbent challenges)
 - ▶ 9 seeking other office (9 House, 2 Senate)
 - ▶ Most notable for GMPT issues - Sen. Sandy Pappas - long time bonding chair

DYNAMICS OF UPCOMING SESSION

- ▶ Safety/Security concerns coupled with construction make access even more difficult
- ▶ State budget still wobbly and will impact discussions
- ▶ Every election year is dramatic, but 2026 may be extra
 - ▶ Every legislative seat plus statewide offices up for election
 - ▶ Speaker of the House (plus 2 other state reps) challenging Gov. Walz
 - ▶ Two state representatives seeking to become auditor
- ▶ Gridlock may worsen
 - ▶ No one wants to give other side a win
 - ▶ Fears of primary challenges may hamper compromise
- ▶ Ongoing federal presence may worsen already frayed relationships
- ▶ Focus on fraud could result in overcorrections and/or lack of focus on other items
- ▶ Even year typically a bonding year, but . . .

Shorter session and tighter timelines

Calendar

- ▶ February 17 Session Starts
- ▶ March 27 1st & 2nd Committee deadline
- ▶ Easter/Passover break - March 27 at 5 PM - April 7 8:00 AM
- ▶ April 17 3rd Committee deadline
- ▶ May 18 Legislature must adjourn

Practical impact

- ▶ Fewer hearings. Each House co-chair has 6 hearings before deadline
- ▶ Less time to get work done
- ▶ Less time for shenanigans

Will they pass any bills?

- ▶ This could be a do-nothing session
- ▶ Most likely bills to pass - State Government Finance
 - ▶ Tax?
 - ▶ Bonding?
 - ▶ Legacy?

BONDING: *IF HISTORY'S ANY GUIDE, OH BOY*

- ▶ Even year is traditional bonding year, but schedule has been off for more than a decade:
 - ▶ 2016 failed, passed in 2017
 - ▶ 2018 passed, but water funding delayed due to structure. Repassed in 2019
 - ▶ 2020 failed in regular session, passed during 5th special session in late fall
 - ▶ 2022 failed, passed in 2023
 - ▶ 2024 failed, passed in 2025
 - ▶ Could 2026 be any different?!

WILL THEY PASS A BONDING BILL?

WHY THEY MIGHT

- ▶ Bonding chairs/co-chairs, minority lead really want it
- ▶ Lack of local projects in 2024 bill
- ▶ Agencies and state programs still playing catch up
- ▶ Demand is high! \$3.8 billion state agency and \$2.7 billion local government requests

WHY THEY MIGHT NOT

- ▶ Election year politics
- ▶ Increasing number of legislators who don't like bonding bills
- ▶ Worsening budget forecast
- ▶ “We passed one last year”
- ▶ “I support infrastructure, but I can't vote for that stuff”

GMPT's Legislative Policies and Agenda

- ▶ Legislative policies guide our work at the Capitol
 - ▶ Our policies focus on ensuring that we have our fair share of funding for regional and local parks and trails, that we are supporting the Commission and they support our members, and that the Legislature does not place undo burdens on our ability to build parks and trails
 - ▶ Examples of problematic legislation include efforts to block funding for any park or trail that has used eminent domain, restricting the price at which land can be built, blocking any use of eminent domain
- ▶ Legislative agenda guides the specific issues that we will be working on.
 - ▶ We will introduce bills on some, but not all of these issues

Legislative Agenda for 2026

The GMPT supports legislation that will update and modernize the authorizing language for the Greater Minnesota Regional Parks and Trails Commission.

The GMPT supports legislation that would allow extend the expiration date of and allow unspent parks and trails legacy funds to be reallocated to other projects.

The GMPT supports the passage of a Legislative-Citizens Commission on Minnesota Resources bill that includes funding for the Local Trail Connections, Outdoor Recreation, and Natural and Scenic Area grant programs and for selected local and regional park and trail projects.

Greater Minnesota Parks and Trails (GMPT) supports a robust bonding bill that includes a bonding appropriation of at least \$4,000,000 to the Department of Natural Resources (DNR) to fund the local and regional grant programs under Minn. Stat. 85.019 and additional funding for local and regional parks and trails.

Translating the Agenda & Policies into Legislation

- ▶ Legislation - Changes to the Commission language AND extend funding for several projects.
- ▶ Other legislation
 - ▶ Support passage of LCCMR bill that include funding for local grants as well as member projects
 - ▶ Support inclusion of local parks and trails grants in final bonding bill
- ▶ Bill numbers, handouts, more will be available when session starts

What else could we be seeing?

- ▶ Policy restrictions -
 - ▶ Eminent domain use in legacy projects
 - ▶ Other?
- ▶ Tightened policies (and higher overhead) for grants
- ▶ Tweaks to the community grant program ??

GMPT's Legislative Advocacy & Your Role



At its core, GMPT founded to advocate for the parks and trails of Greater Minnesota



Legislative Advocacy (AKA lobbying) is a team sport

Lead at legislature is our lobbyist, Elizabeth Wefel
Board/Executive Team drives the ship with our legislative policies/agenda as the guide stone
Our members play a crucial role as voices to their own legislators and other key legislators

Preparing for success

Strong relationships are the foundation for success

Get to know your legislator before you need to ask them for something

Your goal: Your Legislators know you by name

How do you build the relationship?

Invite	Invite them to a park board meeting or similar gathering
Arrange	Arrange tour or visit to city facility. Include them at all openings
Recognize	Recognize their work and contributions publicly
Stop by	Any time you are in St. Paul, stop by your legislator's office and leave a note if they aren't there
Repeat	Schedule regular get togethers. Relationships take time and persistence

How do you build the relationship?

Introduce	Introduce yourself and your position
Congratulate	Congratulate them on winning election/reelection
Ask	Ask for a meeting - formal or informal
Stop by	Stop by in-district “office hours”
Attend	Attend a townhall meeting
